

XVI. A REPORT ON THE AMPHIBIANS AND REPTILES OF OKLAHOMA.*

Last year a preliminary list of the snakes of Oklahoma was published.¹ This included those specimens with definite localities, which were at that time in the Field Museum, the U. S. National Museum, and the University of Oklahoma Museum of Zoology. The report this year is based upon all amphibians and reptiles with definite localities that are known to be in collections of the following museums: Academy of Natural Sciences of Philadelphia, American Museum of National History, Field Museum of Natural History, U. S. National Museum, the University of Michigan Museum of Zoology, and the University of Oklahoma Museum of Zoology (U. O. M. Z). No specimens from Oklahoma are in the collections of the Museum of Comparative Zoology or of the California Academy of Sciences.

It is to be expected that any state university museum of zoology would have the largest collection from its own state, and of course this is the case in Oklahoma. When numbers are not designated in this list the specimens are in the University of Oklahoma Museum of Zoology. Our entire taxonomic knowledge of the herpetological fauna of Oklahoma at this time is indicated in this list. A few species of snakes were reported in the preliminary list of 1924, of which no further specimens have been secured; these species are included in the present report in order to make the list of species from the State complete to date and are here marked with an asterisk.

It has been possible to spend only a very small part of two years in an attempt to make a representative state collection. It will be noted of course that most of the specimens are from only a few counties, mostly those in the southeast and east central part of the State. No collecting has been done in the southwestern part of the State except in Comanche County. None has been done in the panhandle or even in the old "Neutral Strip" (those counties from Kay and Noble west to the 100th meridian).

Specimens from old collections labeled "Neutral Strip" are

not listed here unless they constitute the sole record for a species. In general only those specimens are recorded which have locality data at least as definite as the county.

The only careful collecting that has been done was during June and July of 1925 when the Museum sent an expedition into the field. This party consisted of three students,—J. E. Gilliam, G. S. Caughron, and Jack R. Caughron—Mrs. Ortenburger, and the author. All members of the party are responsible for the collections in all of the vertebrate classes. In all, some 115 lots of amphibians and some 350 lots of reptiles were collected. Practically all of these were from the following counties: Le Flore, McCurtain, Pushmataha, Choctaw, Love, and Comanche Counties, with the great majority of the specimens from the first three named.

Last year the Museum was fortunate in obtaining a good collection from Okmulgee County made by a student, Miss E. R. Force of Okmulgee.

We have, then, representative collections so far from McCurtain, Le Flore, Pushmataha, and Okmulgee Counties. There are also in the Museum small, but most instructive collections from Creek, Tulsa, Choctaw, Carter, Love, Comanche, and Cleveland Counties. Primarily from other museums we have a few records from Woods, Muskogee, Haskell, and Caddo Counties. Unfortunately these are all the collections that are known. It will be noticed as stated above that all of the fairly representative collections are from either the southeastern part of the state or the central eastern portion. In other words, collections worthy of the name are available from only five per cent of the 77 counties of the State. It is evident, therefore, that the list is necessarily very incomplete, but it seems worth while to record it due to the paucity of published information concerning amphibians and reptiles of Oklahoma. To the herpetologist the list will speak for itself, but perhaps some of the more interesting forms should be mentioned.

Of note among the amphibians are: *Desmognathus fuscus brimleyorum*, which has previously been recorded only from Arkansas; *Triturus viridescens louisianae*; *Pseudacris occidentalis*, formerly known only from Arkansas and Texas; and *Gastrophryne carolinensis*.

Of the lizards the most interesting species found is *Eumeces anthracinus*, the taxonomic status of which had formerly been in doubt. Only two specimens were taken, one near the Kiamichi

River under a rotten log in a low wet place along a railroad fill, the other in the Wichita National Forest in Comanche County. *Eumeces obsoletus* and *E. pachyurus* are two other interesting forms of the same genus. It is worthy of note that ten specimens of *Anolis carolinensis* were found in McCurtain County along the Red River and north of Broken Bow. It is of interest that the 97th meridian seems to separate the ranges of the two subspecies of *Sceloporus* in the State, *Sceloporus undulatus thayerii* (*u. consobrinus*) occurring west of it and *S. u. undulatus* to the east.

Several interesting snakes may be mentioned: *Leptotyphlops dulcis*, for example, from Kiowa and Cleveland Counties; *Arisona elegans elegans* from Woods County; *Cemophora coccinea* from Okmulgee County; *Natrix septentrionalis* from Okmulgee County; *Natrix rigida* from Choctaw County; *Natrix sipedon sipedon* from McCurtain County which had not hitherto been found south of Kansas; *Natrix fasciata confluens* from southern Oklahoma; *Potamophis striatulus* from both Adair and Okmulgee Counties; and *Tantilla gracilis* from several counties. Many great range increases might also be mentioned in detail but they are obvious to those interested.

Perhaps the turtles form a more unusual list than any of the other groups. Among the forms should be mentioned *Sternotherus carinatus*, *Deirochelys reticularia*, *Pseudemys troostii*, and *Graptemys pseudogeographica kohnii*. Three species of *Amyda* were collected last summer, *A. emoryi*, *A. mutica*, and *A. spinifera*.
