

ated than other leaders. They embraced many of the ideals of American liberal democracy and shared values with those in the conservative mainstream. The Q analysis provides some important insights into the types of individuals who become leaders of third parties. It adds an important dimension to the book that is not present in earlier studies of third parties.

An understanding of third parties is greatly improved by this book. It is extremely informative, and yet interesting and engaging, which cannot be said for many scholarly books about politics.
